# **Proof of Consent**

### 1. Introduction

Our website, <a href="https://earth4all.life">https://earth4all.life</a> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). #### 2. What are cookies?

### 3. What are scripts?

A script is a piece of program code that is used to make our website function properly and interactively. This code is executed on our server or on your device.

### 4. What is a web beacon?
